

# Solon Sportsmen's Association Richmond Township, OH 2010 HP Rifle Program - NRA Sanctioned 800 Point Matches

**4 NRA Sanctioned Matches:** Competitors scores and NRA registration fees are sent to NRA competitions at year's end and count toward your NRA HP or F-Class classification. F-class positions are new this year.

**Dates:** Sat-May 8<sup>th</sup>, Sat-June 12<sup>th</sup>,  
Sat-July 10<sup>th</sup>, Sat-Sept 11<sup>th</sup>.  
Sat-Oct 09<sup>th</sup> rain date. E-mail for status

**Location:** SSA club grounds. 5426 Footville-Richmond Rd. Richmond Township, OH 44003

**Directions:** I-90 to SR11 exit 228.  
SR11 South to SR 307. East on 307 to SR193.  
North on SR193 to Footville Richmond Rd.  
East on Footville Richmond Rd. to Club  
Property approximately 2 mi. on the right.

**Time to arrive:** Front gate will be open from 6:45 am until 7:45 am. for sign in and squadding.

**Squadding:** Sign in and squadding is at the building just inside the gate between 6:45 and 7:45 am with final adjustments made on the 300 yard line. Match will begin at approximately 8:00 am. Four relays are planned. All competitors must present themselves when their relay is called, and report for his duty in the pits before they seal to be scored in this event.

**Time of Firing:** Pits will seal at 8 a.m. Firing will begin thereafter from the 200 yard line.

**Range capacity:** 64 with 4 relays. This match is limited to 40 shooters.

**Entries at the match:** Until 7:45 a.m.

**Entries by mail:** None

**Rules:** Current SSA, & NRA Competition rules will apply.

**Eligibility:** SSA & Non SSA members are welcome. All match entrants should be fully completely familiar with NMC procedures. Competitors must sign a 2010 liability agreement. Age limit is 14 years or older. (Note 1) All rifles shall have a known 200 yard zero, minimum. (Note 2)

**Fees:** \$20 per shooter. Solon Members pay \$10.

**Rifles Allowed:** Service or Match. NRA Rules 3.1, 3.1.1, 3.1.2. There will be two divisions of Champs: NRA Match Rifle and Service, unless there are less than 5 rifles in a class, If so, they will be combined.

**Ammunition:** Competitors must supply their own ammunition. No incendiary or tracer ammo is permitted.

**Sights:** Metallic Sights Only

**Sighters:** Two sighting shots are allowed prior to each match. Sighting shots may be taken in a position other than that specified for the match, but such position must be one of those described in Rule 5 of the High Power Rifle Book, except 5.13.

**Course of Fire:** NRA 7.15

**Match 1** Standing Slow Fire  
20 shots for record slow fire,  
20 minutes @ 200 yards

**Match 2** Sitting/kneeling Rapid Fire (Note 4)  
20 shots for record in 2-10 round strings,  
60 seconds each, rapid fire @ 200 yards.

**Match 3** Prone Rapid Fire (Note 4)  
20 shots for record in 2-10 round strings,  
70 seconds each, rapid fire @ 300 yards.

**Match 4** Prone Slow Fire  
20 shots for record  
20 minutes @ 600 yards

**Match 5** The match winner: aggregate of 1-4

**Note 1** – The Match RSO may waive the age requirement upon the presentation of evidence that the applicant has successfully competed in other shooting competitions or can provide satisfactory proof of having demonstrated the ability to safely handle the pistol or rifle to be used in that event.

**Note 2** - If your rifle does not have a known zero, you must notify the line officer.

**Note 3** – At season's end, your scores will be reported to the NRA for classification updates.

**Note 4** – NRA 2009 rules no longer require shooters to stand and load in the rapids.
